



## AIEN 2022 Awards Methodology

The AIEN 2022 International Energy Summit (IES), being held in London, UK, will feature an Awards Dinner on September 28 where esteemed professionals & organizations will be recognized for their outstanding achievements in the energy industry. The objective of the annual AIEN Awards is to celebrate certain impactful industry achievements, underpinned by international energy negotiations and transactions that promote and embody the principles of AIEN in the energy industry.

### Award Categories

#### ***Deal of the Year***

This award recognizes an outstanding and noteworthy M&A transaction, occurring between January 1, 2021 to December 31, 2021, and having been announced or made public.

#### ***Venture of the Year***

This award recognizes a new and significant commercial partnership, joint venture, arrangement or initiative (other than an M&A deal), occurring between January 1, 2021 to December 31, 2021, and having been announced or made public.

### ***Discovery of the Year***

This award will be given to a company who has made a highly significant oil or gas discovery, or an addition to discovered resources through exploration and appraisal activities, occurring between January 1, 2021 to December 31, 2021, and having been announced or made public.

### ***Energy Innovation***

This award recognizes nominees that are demonstrating true leadership in innovative ways in the transition to a low-carbon, sustainable future. Nominations should describe how the nominee is leading the way in reducing carbon impacts through technology and innovation or creating targets to manage performance and aligning with global energy transition commitments.

### ***Corporate Social Responsibility Campaign of the Year***

The Corporate Social Responsibility (CSR) Campaign of the Year Award illuminates the ever-important convergence of profitability and company values. The judges will seek a high-performing organization that has demonstrated its positive influence on surrounding communities, promotes teamwork toward sustainable, long-term impacts, and encourages active employee participation beyond financial contributions. Judges will focus exclusively on all sustained programs that were launched beginning between January 1, 2021 to December 31, 2021.

## **Award Methodology**

In the interest of transparency, AIEN's award methodology is detailed below.

1. The AIEN "call for award nominations" will take place during a 7-week period. The award nominations period will open on May 26, 2022 and close on July 14, 2022. AIEN members will receive email notifications when the call for award nominations open, as well as reminders prior to the deadline. The call for award nominations will also be posted on the AIEN 2022 IES website.
2. Only AIEN members in good standing are eligible to make nominations. Members may nominate others or self-nominate. Nominees do not need to be AIEN members to qualify.
3. Nominating members will be asked to specify:
  - a. the Deal, Discovery, Venture, Energy Innovation or CSR Campaign that they are nominating;
  - b. the reason(s) why they believe it should win the award (200 words max); and
  - c. any individuals whose contributions they believe should be specifically recognized in conjunction with the award.

Any information included in the nomination should be in the public domain.

4. AIEN staff will compile all nominations and submit them to the Awards Committee.
5. The Awards Committee will review each nomination submission independently and decide if it:
  - a. Meets the criteria of the award category; and
  - b. Promotes or demonstrates the principles of AIEN.

Each and every nomination will be carefully considered by the Awards Committee, consisting of AIEN members from across its regional chapters. The committee will discuss the candidates and decide on the top three finalists of each category. Once finalists have been decided, the committee will select each category winner through a committee vote. The Awards Committee reserves the right to forgo giving an award in any particular year.

## **Timeline**

May 26, 2022 – Call for award nominations open

July 14, 2022 – Call for award nominations close

July 18, 2022 – Nominations are sorted and forwarded to Awards Committee

August 15, 2022 – Finalists are announced

September 28, 2022 – Award winners are announced at the 2022 IES Awards Dinner
