## **Program Description**

So, what can go wrong? How many times have you heard this expression just before a major decision is made? There are an infinite variety of upstream oil and gas projects, each having its own unique set of risks. Companies work in rapidly changing political landscapes with rapidly changing technology which present even more challenges to fully appreciating the various risks. Yet, risk management is not standardized. The ability to quantify and monetize risk is subjective, and thus many times underestimated for complex projects leading to potentially catastrophic results. Identifying, evaluating, and managing risk for international upstream oil and gas projects is a critical step toward insuring predictable results.

This short workshop will serve as an introduction to assist project and business owners to appropriately identify, evaluate, and mitigate above ground risks, develop more effective mitigation plans, and more accurately quantify risks, thus giving predictable results and more successful projects. During the workshop, the participants will be introduced to some practical risk management tools and techniques.
