Boulos, former AIEN president and highly regarded international energy negotiator. Al was active in the international petroleum industry for more than 50 years, serving as AIEN's sixth president, as well as founding the London-based European Petroleum Negotiators Group.</p> <p>Leading petroleum economist Dr. Pedro van Meurs will share his forecast on carbon neutrality targets and the place of petroleum industry in a carbon-neutral world. Dr. Van Meurs will present his analysis of the impact of the energy transition in the coming decades to 2070, concluding that a petroleum industry of considerable size will continue, focusing on producing clean oil and gas supplies for petrochemical and other purposes, and how initiatives to terminate awards of petroleum rights are misguided.
